- 4. The above vacancies are provisional and subject to variation. The Executive Director, AIIMS, Deoghar reserves the right to vary the vacancies including reserved vacancies as per the Govt. of India rules/circulars and requirements. TERMS AND CONDITIONS FOR APPOINTMENT ON CONTRACTUAL BASIS (ASSOCIATE PROFESSOR & ASSISTANT PROFESSOR)

1. Salary: -

Associate Professor: Rs. 1, 88,000/-/- (Rupees One Lakh Eighty-Eight Thousand Only) per month (Consolidated).

Assistant Professor: Rs. 1, 42,406/- (Rupees One Lakh Forty-Two Thousand Only) per month (Consolidated).

- 2. **Upper Age Limit: 50 (Fifty) years**. However, relaxable for Government Servants, PWD (OPH), Scheduled Castes, Scheduled Tribes or otherwise exceptionally qualified applicants up-to **5 years** and **3 years** in case of Other Backward Class (OBC) candidates. No age relaxation would be available to SC/ST/OBC/PWD (OPH) candidates applying for unreserved vacancies. The date of Interview will be the date for considering upper age limit.
