AIIMS Deoghar is an apex healthcare institute, established by the Ministry of Health and Family Welfare, Government of India under the Pradhan Mantri Swasthya Suraksha Yojana (PMSSY) with the aim of correcting regional imbalances in quality tertiary level healthcare in the country and attaining self-sufficiency in graduate and postgraduate Medical education and training.

Applications are invited for the Faculty post of **Associate Professor and Assistant Professor on purely Contractual Basis** for various departments in AIIMS Deoghar for a **period of 1 year or till regular faculty joins** the Institute.

1. **Application Process:** - The applicants fulfilling the eligibility criteria in all respect are required to apply through ONLINE process. Please visit AIIMS Patna website <https://aiimspatna.org> for online application. The closing date of online applications will be 30 days from advertisement of the post in Newspaper.
2. A copy of the online filled up application should be downloaded. A **print out of the online submitted application, Proof of application fee deposit by Online Mode along with the requisite documents as per Para 9 of General Conditions, is to be self-attested, and sent by Speed post/ Registered post only addressed to Recruitment Cell, AIIMS Patna, Phulwarisharif, Patna- 801507.**
3. The envelope containing the printout of the online application should be printed/ written with: "**Application for the contractual post of ..... AIIMS Deoghar (Advt. No)..... “to Recruitment Cell, AIIMS Patna.** It should be posted by the last date of online submission of application.
4. The applicants are required to register themselves at AIIMS Patna recruitment portal through link available at recruitment page at <https://aiimspatna.org>.

5. After primary registration they will receive a confirmation e-mail. This confirmation email will also have applicant ID and a password to login into the system and fill in the application online.
6. The candidates should read the instructions carefully on the recruitment portal before filling the application.
7. Interview may be spilled over to next day. Therefore, candidates should be available for next day also, if necessary.
8. The applicants are required to pay a non-refundable application fee of Rs. 1500/- (for General & OBC Candidates) and Rs. 1200/- (for SC/ST/EWS Candidates). There is no fee for PWD Candidates. Application fee once paid will not be refunded under any circumstances.
9. The applicant should upload the scan copy of Photograph, Signature, **Aadhar Card**, Date of Birth, Category Certificate (if applicable), Qualification (10<sup>th</sup>, 12<sup>th</sup>, MBBS/BDS, MD/MS/MDS, MCI Registration MBBS and MD/MS, DCI Registration for BDS and MDS, MCI Registration Post Doctorate and Teaching and Research Experience Certificate in the form of PDF /Image. The size of each scanned pdf should not exceed 1 MB each.
10. The applicants applying in response to this advertisement should satisfy themselves regarding their eligibility for the post applied for. They must be fulfilling the eligibility criteria as on the closing date of application failing which their application will be rejected.
11. The candidate must ensure that their coloured photograph and signature should be clearly visible in preview at the time of filling of application in online mode.
12. The decision of the Executive Director, AIIMS Deoghar in this regard shall be final and binding. The offer of appointment when made will be provisional and subject to verification of credentials (Educational & Personal) by the competent authority. The vacancies are provisional and subject to variation. The Executive Director, AIIMS, Deoghar reserves the right to vary the vacancies including reserved vacancies. No correspondence whatsoever would be entertained in this regard.
13. Those who are working in Central/State Government/Semi Government/ Autonomous Institution must submit a **“NO OBJECTION CERTIFICATE”** from the employers at the time of Interview.
14. Candidates appearing for interview will have to produce all relevant documents in **original** as proof of details furnished in their application at the time of interview/joining.

15. The Interview will be held at **All India Institute of Medical Sciences, Panchayat Training Institute (Temporary AIIMS Campus) Daburgram, Jasidih, Deoghar-814142 (Jharkhand)**. No TA/DA will be paid for appearing in the Interview.
16. Canvassing of any kind will lead to disqualification. The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection.
17. The candidate should not have been convicted by any Court of Law.
18. The selected candidate is expected to conform to the rules of conduct and discipline as applicable to the institute employees.
19. In case of any information or declaration given by the candidate is found to be false or if the candidate has wilfully suppressed any material information relevant to this appointment, he/she will be liable to be removed from the service with immediate effect and action will be taken as deemed fit by the appointing authority.

22. Appointment of selected candidates is subject to his/her being declared medically fit by the competent Medical Board.
23. Selected candidates have to join within 15 days of publication of result in the Institute Website and receiving of Appointment Letter.

## **TERMS AND CONDITIONS FOR APPOINTMENT ON CONTRACTUAL BASIS (ASSOCIATE PROFESSOR AND ASSISTANT PROFESSOR)**

### **1. Salary: -**

**Associate Professor: Rs. 1,88,000/-** (Rupees One Lakh Eighty-Eight Thousand Only) per month (**Consolidated**).

**Assistant Professor: Rs. 1,42,506/-** (Rupees One Lakh Forty Two Thousand Five Hundred Six Only) per month (**Consolidated**).

2. **Upper Age Limit: 50 (Fifty) years.** However, relaxable for Government Servants, PWD (OPH), Scheduled Castes, Scheduled Tribes or otherwise exceptionally qualified applicants up to **5 years** and **3 years** in case of Other Backward Class (OBC) candidates. No age relaxation would be available to SC/ST/OBC/PWD (OPH) candidates applying for unreserved vacancies. **The last date of submission of application will be considered as the date for upper age limit.**
3. The appointment is purely on **CONTRACT BASIS for a period of 1 year or till regular faculty joins**, whichever is earlier, with effect from the date of joining. **However, the contractual appointment shall not be extended beyond the period of two years.** If the contract is not extended further, the same will lapse automatically. The appointment can also be terminated at any time, on either side, by **giving one month's notice or by paying one month's salary.**
4. The appointee shall not be entitled to any benefit like Provident Fund, deduction of NPS Subscription, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc. or any other benefits available to the Government Servants, appointed on regular basis.
5. The appointee shall perform the duties as assigned to him/her. The competent authority reserves the right to assign any duty as and when required. No extra/additional allowances will be admissible in case of such assignment.
6. The appointee shall not be granted any claim or right for regular appointment to any post of AIIMS, Deoghar.
7. The appointee shall be on the whole-time appointment of the AIIMS Deoghar and shall not accept any other assignment, paid or otherwise and shall not engage himself/herself in a private practice of any kind during the period of contract.
8. Leave entitlement of the appointee shall be governed as per rules.
9. On appointment, the appointee will be required to take an oath of allegiance to the Constitution of India or make a solemn affirmation to that effect in the prescribed Performa.

10. The appointee is not entitled to any T.A. /D.A. for attending the interview and joining the appointment.
11. Other conditions of service will be governed by relevant rules and orders issued from time to time.
12. If any declaration given or information furnished by him/her proves false or if he/she is found to have wilfully suppressed any material, information, he/she will be liable for removal from service and also such other action as the Government may deem necessary.
13. The appointee shall not be entitled to avail any allowances/facilities being extended to the regular/permanent faculty members of the AIIMS, Deoghar.
