- 1. Selection Venue: MRU, Third floor, Academic building, AIIMS Deoghar. No TA/DA will be paid for attending the walk-in interview/written examination.
- 2. Age Concession: Age relaxation is admissible in respect of SC/ST/OBC/OPH candidates, Retrenched Government Employees, Departmental Candidates (including projects), and ex-servicemen in accordance with the instructions issued by the Central Government from time to time. Age concession to the extent of services rendered in the research projects will also be admissible for experienced and skilled people. The effective date for fulfilling eligibility criteria (including qualification and experience etc.), upper age limit will be the date of the walk-in interview/written examination.
- **3.** Date and Time of the walk-in interview/written examination. 11:00 am onwards on (Date to be announced). The Candidates shall report by 9:30 am at the selection venue.
- **4.** The candidates shall report with
  - 1. Duly filled application form
  - 2. Self-attested photocopies of proof of date of birth (class 10<sup>th</sup> certificate/ school leaving certificate), eligibility qualification mark-sheets, degrees, experience certificate, caste certificate, qualifying degree registration with statutory council (if applicable) and other relevant testimonials.
