


**Minutes of the 5th Meeting of the Institute Body (IB) of AIIMS Deoghar held at

Appeal against the penalty for withholding of increment awarded to Dr. Arpan Haldar, Associate Professor, Dept. of Anatomy, AIIMS Deoghar

The Member Secretary informed the Institute Body of the Minor Punishment of "Withholding of next increment for a period of one year without cumulative effect" awarded to Dr. Arpan Haldar by the Disciplinary Authority i.e. the President, AIIMS Deoghar.

The Appeal preferred by Shri Arpan Haldar was also placed before the IB for consideration.

Status: The IB suggested to prepare the details of the case and circulate to the newly constituted Governing Body which is the Appellate Authority. The Governing Body to consider and decide on the appeal accordingly.

IB 05/11

Appeal against the penalty for reduction in time-scale of pay awarded to Dr. Arpan Haldar, Associate Professor, Dept. of Anatomy, AIIMS Deoghar

The Member Secretary informed the Institute Body of the Minor Punishment of "Reduction of lower stage in time-scale of pay by one stage for a period of three years, without cumulative effect and adversely affecting his pension" awarded to Dr. Arpan Haldar by the Disciplinary Authority i.e. the President, AIIMS Deoghar.

The Appeal preferred by Shri Arpan Haldar was also placed before the IB for its consideration.

Status: The IB suggested to prepare the details of the case and circulate to the newly constituted Governing Body which is the Appellate Authority. The Governing Body to consider and decide on the appeal accordingly.

IB 05/12

To consider and approve notional promotion for Assessment Promotion Scheme Candidates

The Member Secretary briefed the IB about the 26 faculty members eligible for APS and representation received from the 05 faculty members for consideration of their candidature for Assessment Promotion Scheme (APS), since their juniors were eligible. It was further informed to the IB that based on the report of a committee constituted for this purpose and approval of the President, AIIMS Deoghar, their candidature was considered subject to ratification of the statutory bodies (GB/IB).

The Member Secretary also placed before the IB the representation received from Dr. Anita Kumari, Associate professor from Department of Physiology regarding denial of promotion under the Assessment Promotion Scheme under the SSC Meeting held on 15-10-2025.

Status: The IB ratified the candidature for APS of 31 faculty members and allowed for notification of result.

The IB further suggested for constituting a three (03) member committee from amongst the Governing Body Members to examine the representation of Dr. Anita Kumari, based on the existing records. Chairperson, Governing Body was requested to constitute the three member committee accordingly.

IB 05/13

To consider & approve starting M.Sc, PDCC and PhD Courses at AIIMS Deoghar

The Member Secretary informed the IB members about the proposal of the institute to start M.Sc course with 08 seats initially (02 each in Anatomy, Physiology, Pharmacology & Biochemistry), PDCC course with 11 seats (02 in critical care and 01 each in Paediatric Anaesthesia, Onco Anaesthesia & Onco critical care, Pain Medicine & Palliative Care, Neuro Anesthesia & Neurocritical Care, Cardiac Anesthesia, Trauma Anesthesia & Trauma Critical Care, Paediatric Endocrinology, Pediatrics allergy & asthma, Post Doctoral fellowship in joint replacement & reconstruction) and PhD Course with 05 seats (01 each in Pathology, Biochemistry, Microbiology, Community & Family Medicine and College of Nursing)

Status: The IB approved the proposal to start M.Sc, PDCC & PhD courses. The IB further advised the institute to ensure sufficient case load as well as to explore the possibility of a part time PhD course, after due deliberation from the Standing Academic Committee.

IB 05/14

To consider & approve establishment of IVF facility at AIIMS Deoghar with the financial aid from Satsang, Deoghar

The Member Secretary informed the IB members regarding the kind consent of Satsang Organization, Deoghar for providing donation / financial assistance for establishment of IVF facility at AIIMS Deoghar. The Member Secretary further briefed the IB that the proposal is on a turnkey basis and includes capital expenditure as well as the operational expenditure for a period of one (01) year. The estimated approximate cost of the project is ₹ 8 to 9 crores.

Status: The IB appreciated the proposal and the financial assistance being provided by the Satsang organization. The IB however advised the institute to explore the possibilities of long term MoU (05 years or longer) with the Satsang to cover capital and operational expenditure. The IB also advised to place the matter as an agenda item before the Standing Finance Committee for ratification of the donation. The President, AIIMS Deoghar also advised the Institute to make available the service of IVF at reasonable rates for the needy patients.

IB 05/15

To consider and approve establishment of Vishram Griha at AIIMS Deoghar

The Member Secretary informed the IB members regarding the proposal of the Sevedan Arogya Foundation for construction and operation of Vishram Sadan at AIIMS Deoghar. It was further informed to the IB Members that the Ministry of Health & Family Welfare, GoI has also advised the institute for construction and operation of Vishram Sadan in collaboration with the Sevedan Arogya Foundation. The Member Secretary briefed the members that the Vishram Griha shall be built and operated by Sevedan Arogya Foundation on a total area of approx. 1000 sq metres near the existing Night Shelter building.

Status: The IB approved the proposal and allowed the institute to sign the MoU with Sevedan Arogya Foundation as approved by Ministry of Health and Family Welfare.

IB 05/16

Adoption and Notification of Central Government Service Rules as applicable under rule 35 of AIIMS Regulations, 2019

The Member Secretary briefed the IB that the institute presently follows the Central Government rules/ guidelines for service, establishment and administrative matters. Rule 35 of the AIIMS Regulations, 2019 also provides that in matters not provided in these regulations, the rules as applicable to the Central Government servants and orders and decisions issued in this regard by the Ministry of Health & Family Welfare from time to time shall apply to the employees of the institute. The Member Secretary thus sought the approval of the IB for formally adopting and notifying the these rules particularly on resignation / technical resignation, promotion & DPC guidelines, Vigilance Clearance, Liaison Officer for SC/ST/OBC/PwD/ESM/EWS, Instructions on bond, Disciplinary proceedings, LTC, Recruitment Rules framing/ amendment/ relaxation, Deputation / Foreign Service, Ad-hoc promotion / appointment, Reservation for SC/ST/OBC/PwD/ EWS, Honorarium to IO/PO, Representation on Service Matters, Prevention of Sexual Harassment of working women and any other rules/ instructions/ guidelines applicable to Central Government servants, but not explicitly mentioned in the AIIMS Regulations, 2019

Status: Approved.

Adoption of applicability of DoPT's instructions related to Technical Resignation in new AIIMS

The Member Secretary informed the IB that Technical Resignation guidelines including the benefit of lien, pay protection, applicability of pension scheme, GPF transfer etc have been approved by the MoHFW Memorandum No-Z-28016/192/2020-PMSSY-IV-Part (1) (8149336) dated:- 25.11.2025. The Member Secretary asked for the approval of the IB for adopting the DoPT's instructions related to Technical Resignation in all new AIIMS, and accordingly the seniority of employees of the Institute in each category shall be determined as per the guidelines mentioned in the memorandum.

To consider & approve delegation of Financial & Administrative Powers

The Member Secretary informed the IB that in order to ensure quick and effective decision making, a notification for delegation of financial & administrative powers has been prepared based on the needs of the institute. The Member Secretary sought the approval of the IB on the proposed delegation of Financial & Administrative powers.

Status: Approved.

Information & Ratification of the minutes of the 06th Standing Finance Committee Meeting

The Member Secretary placed the minutes of the 06th Standing Finance Committee meeting held on 10th October, 2025 at the Ministry of Health & Family Welfare for information and ratification of the IB.

Status: Ratified.

IB 05/20(a)

Approval for Selection of Shri Alok Arya as Security Officer on Contractual Basis.

The Member Secretary informed the IB that the institute is in an urgent need of a Security Officer to manage the overall security of the institute. Since a regular post is not sanctioned, the same has been approved in the SFC for engaging on contractual basis. The interview for the contractual post of Security Officer was held on 20th January, 2026 in which only one candidate Mr. Alok Arya appeared.

Mr. Alok has served as Assistant Commandant at BSF and then as Manager (Security) at Bank of India with a total experience of approx. 13 years. The age limit prescribed for the post of Security Officer as Recruitment Rules is 18-35 years. However, the age of Mr. Alok Arya as on last date of application is 38 years & 8 months and thus, he is not eligible. The Member Secretary sought approval of the Institute Body for a one-time relaxation in the eligibility criteria for appointment of Mr. Alok Arya as Security Officer on contractual basis for eleven months keeping in view the urgent requirement of the institute.

Status: The IB approved the appointment of Shri Alok Arya as Security Officer on contractual basis for a period of eleven months or till the joining of a regular incumbent, whichever is earlier, with a one-time relaxation in the prescribed age limit. The IB further advised the institute to initiate action for appointment of Security Officer on regular or deputation basis.

IB 05/20(b)

Approval for Selection of Smt. Rubina Naz as Senior Programmer on Contractual Post.

The Member Secretary informed the IB that the institute is in an urgent need of a Senior Programmer to manage the overall IT Infrastructure and cyber security apparatus of the institute. Since a regular post is not sanctioned, the same has been approved in the SFC for engaging on contractual basis. The interview for the contractual post of Senior Programmer was held on 20th January, 2026 in which only two candidates viz. Ms. Rubina Naz and Ms. Sunita Kujur had appeared.

The experience criteria for the said post was ***BE/ B.Tech/ MCA/ B.Sc with Diploma in Computer Application and 10 years' experience in IT System/ Networking/ Hardware Configuration/ Software Programming in Ministries/ Departments of India/ State Government/ UTs/ Statutory/ Autonomous Bodies***. Ms. Sunita Kujur was eligible as per the eligibility criteria, however, was not found suitable by the interview board. Ms. Rubina Naz was found suitable for the said post; however, she was having the requisite experience from private sector, rather than the Government Sector.

The Member Secretary sought approval of the Institute Body for a one-time relaxation in the eligibility criteria (experience in Government Sector) for appointment of Rubina Naz as Senior Programmer on contractual basis, keeping in view the urgent requirement of the institute.

Status: The IB did not accord approval for grant of one-time relaxation in eligibility criteria. The IB advised that the result of the present selection process be declared as "None Found Suitable" and the post be re-advertised with revised eligibility criteria to attract a wider pool of technically qualified candidates.

IB 05/20(c)

Any other agenda with the permission of the chair

Dr. Nishikant Dubey, Hon'ble MP and Member, Institute Body / Governing Body suggested that engagement of outsourced manpower may be undertaken after due verification of domicile, based on Aadhaar and Residence Certificate. He further suggested that the Institute may explore execution of a Memorandum of Understanding (MoU) with Damodar Valley Corporation (DVC) for ensuring uninterrupted power supply, and with C-DAC for IT solutions, in view of the proposed commencement of local operations of C-DAC at Deoghar.

Prof. Kshiti Bhushan Das suggested exploring the feasibility of starting a course in Geriatrics and also proposed collaboration with other institutes such as Central University of Jharkhand (CUJ) for studies and research in areas including Sickle Cell Anaemia.

Dr. Pradeep Bhatia proposed adoption of an end-to-end IT solution for the Institute, keeping in view the increasing dependency on IT systems for academic, clinical, and administrative functions.

Prof. Rajshree and Prof. Sukumar Mishra suggested making provision for installation of rooftop solar panels for power generation within the Institute.

In her closing remarks, Prof (Dr.) M. V.
