- 1. The number of posts is tentative and is liable to change based on the Institute's requirements. These posts are advertised as per the approved existing Recruitment Rules. - 2. Maximum age limit for applying for the aforesaid posts on deputation in 56 years as on last date of receipt of application. Incomplete applications or applications received after the last date are liable to be rejected.
- 3. The initial period of deputation shall be 5 years.
- 4. The post carry usual allowance as admissible to central Government Employees of similar status stationed at Deoghar (Jharkhand).
- 5. The Officers, who fulfil the above qualifications/ Eligibility, may submit their application through proper channel in prescribed proforma as per Annexure -1 and Annexure-2 attached with this Vacancy Circular/ Advertisement to the Dy. The last date of receipt of application in AlIMS Deoghar will be 30 days from the date of publication of this advertisement in the employment News. Separate application is required for each post. - 6. The envelope containing the application(s) should be super-scribed "Application for the Post of ......................" While forwarding the applications, it may be ensured that the particulars of the candidates are verified and they fulfil the eligibility conditions. Duly attested photocopies of their up to date qualification, experience certificates, promotion/upgradation orders and Confidential Reports (at least for the latest 05 years) may be enclosed with the applications.
