- 4. The appointment of the provisionally selected candidate will be strictly subject to verification of all original certificates of the candidate. - 7. Candidates who have been allocated Institute are mandatorily required to select the option to ACCEPT the offered seat within the dates specified. Following Options will be available as per allocation of Institute:

#### 10. Valid Category Certificate

- a. SC/ST caste certificate issued by the competent authority on or before the last date of submission of online application i.e. 18.08.2021 will only be considered for reservation under this category.

OBC certificate/Non creamy layer certificate in English/Hindi, in the format provided by the DOPT vide OM No. 36036/2/2013-Estt.(res.) dated 30.05.2014 and further clarification issued by DoPT OM No. 36036/2/2013-Estt.(res.l) dated 31.03.2016 for appointment to the post under Government of India/Central Government format is required.
- c. The vacancies are being advertised in financial year 2020-2021, therefore, valid NCL-OBC certificate issued during the period from 1.4.2020 to 31.3.2021 will be considered valid. Candidature who have NCL-OBC certificate issued before or after this period (i.e 1.4.2020 to 31.3.2021), will not be considered valid for this advertisement.
