AIIMS Deoghar invites applications, through the E-mail to The Registrar Office, AIIMS Deoghar, for the Entrance Interview for admission to the following Post Doctoral Certificate Courses (PDCC) and Post Doctoral Fellowship (PDF) for the July/August 2026 session.

**Eligible candidates may apply online during the application window specified in Section 6 (Important Dates) through the E-mail Registrar Office, AIIMS Deoghar.**

### 4.1 Essential Qualification

A candidate must possess the essential qualification prescribed against the course applied for, as set out in the table below.

## 4.2 Upper Age Limit

- The upper age limit is 45 years as on the prescribed cut-off date.
- Relaxable by a maximum of 3 years for OBC candidates.
- Relaxable by a maximum of 5 years for SC/ST candidates.
- Relaxable by 5 years for Persons with Benchmark Disabilities, as per the Rights of Persons with Disabilities Act, 2016.

### Category certificate requirements:

- For relaxation in application fee or age, candidates of SC/ST/OBC (NCL)/EWS/PWBD category must hold a valid certificate issued by the competent authority in the prescribed format.
- An OBC (NCL) certificate must be issued within one year up to the closing date of the application.
- An EWS certificate must be issued for the relevant financial year, on or after the cut-off date and up to the last date of filling the application form.

## 5. Duration of Course

The tenure of the PDCC course is one (01) year and that of the PDF course is two (02) years, in each case reckoned from the date of joining the course.

The online registration of applications and the interview will be conducted as per the schedule below. The exact dates will be notified on the Institute website.

- The call letter for the interview will be sent to the candidate's registered e-mail (as provided in the application form) well in advance of the interview date.

## 7. Joining

The date for document verification, joining and the last date of admission will be communicated by the Registrar Office after declaration of the result. If a selected candidate fails to join by the stipulated date, it shall be assumed that the candidate does not intend to join, and the seat will be offered to the next candidate on the waiting list.

Candidates are advised to obtain confirmation of successful remittance from their bank and retain the proof, which may be required at the time of document verification.

## 9. How to Apply

---

- Candidates must apply online for the PDCC/PDF course via E-mail Registrar AIIMS, Deoghar as notified by the Institute.
- Fill in all fields carefully. After submission, requests for change in any information at a later stage will not be considered.
- Provide correct details of name, age, sex, category, address, educational qualification and all other relevant fields.
- An application will be treated as INCOMPLETE unless the application fee has been paid.
- Payment of the application fee must be made online / UPI. Additional charges (bank charges, service tax, etc.) shall be borne by the candidate. Retain a printout of the fee receipt.
- Payment by Cash, Cheque, Money Order, Postal Order, Pay Order, Banker's Cheque, Postal Stamps or any other mode will NOT be accepted, and such applications will be summarily rejected. The decision of the Executive Director & CEO, AIIMS Deoghar shall be final and binding, and no refund will be issued.
- The Examination/ Interview details will be sent to the candidate's registered e-mail only, before the date of interview.

### **Documents to be kept ready (self-attested copies, originals at verification):**

- Proof of date of birth (matriculation certificate / equivalent).
- MBBS and MD/MS/DNB degree / provisional certificates and mark sheets.
- Internship completion and permanent/provisional medical registration certificate.
- Category certificate (SC/ST/OBC-NCL/EWS/PWBD), if claiming relaxation, in the prescribed format.
- Recent passport-size photograph and signature.

## 10. Submission of Category Certificate (SC/ST/OBC/EWS)

---

While no reservation applies to these courses, candidates seeking relaxation in age, application fee or other concessions on the basis of their reserved category may submit attested copies of the relevant supporting documents.

Candidates belonging to a reserved category must submit an attested copy of their SC/ST/OBC or EWS certificate (as applicable), in the prescribed format, along with the other required documents. The certificate must be issued by one of the following competent authorities, confirming that the candidate belongs to the SC/ST/OBC/EWS category:

- District Magistrate, Additional District Magistrate, Collector, Deputy Commissioner, Additional Deputy Commissioner, Deputy Collector, First Class Stipendiary Magistrate, City Magistrate, Sub-Divisional Magistrate, Taluka Magistrate, Executive Magistrate or Extra Assistant Commissioner.

- Chief Presidency Magistrate, Additional Chief Presidency Magistrate or Presidency Magistrate.
- Revenue Officer not below the rank of Tehsildar.
- Sub-Divisional Officer of the area where the candidate and family normally reside.
- Administrator / Secretary to Administrator / Development Officer (Lakshadweep Islands), or as authorised under the Constitution.

Candidates will also be required to furnish an undertaking regarding their caste. Any discrepancy detected in the caste certificate will result in cancellation of the candidate's registration. This is in accordance with the provisions of the Ministry of Personnel, Public Grievances and Pensions (Order No. 36033/4/97-Estt. (RES) dated 25.07.2003 and No. 36011/3/2005-Estt. (RES) dated 09.09.2005).

**A certificate issued by any other person or authority will not be accepted. The name, designation and seal of the issuing officer must be clearly legible on the certificate.**

## 11. Service Conditions

---

### 11.1 Penalty on Resignation

A penalty of ₹ 3,00,000 will be imposed if a candidate resigns within the first three months of joining the course, and ₹ 5,00,000 if the resignation occurs after completion of three months from the date of joining.

### 11.2 Senior Residency

Applications are simultaneously invited for the vacant post of Senior Resident in the respective department. Depending on selection outcome, candidates will either pursue the PDCC/PDF course or be absorbed as Senior Resident in the Department.

PDCC and PDF courses are under residency scheme and will follow the rules of residency.

### 11.3 Accommodation

Accommodation shall be provided only to those candidates who are appointed as Senior Residents, and solely subject to its availability.

## 12. Reasons for Rejection / Cancellation

---

Applications and candidature are liable to be cancelled or rejected, summarily or at any stage of the admission process, in the event of any of the following:

- The application being incomplete.
- Any variation in signatures; all signatures in full (not in short) on the application printout and other documents must be identical.
- The photograph or signature uploaded being blurred, distorted or unclear.
- Non-payment of the application/interview fee, or non-receipt of the fee through online mode, where not exempted.
- The candidate being under-aged or over-aged.



- Failure to produce, in original, all relevant certificates and documents along with self-attested legible copies at the time of document verification.
- Not possessing the requisite educational qualification, experience or category status as on the closing date.
- Incorrect information, misrepresentation or suppression of material facts.
- Use of any unfair means or inappropriate behaviour.

### **13. Action Against Candidates Found Guilty of Misconduct**

---

Candidates are strictly cautioned against providing false particulars or concealing any material information while completing the application form. They must not, under any circumstances, alter or tamper with entries in documents or certified copies submitted, nor furnish fabricated or manipulated records. In the event of any inaccuracy or discrepancy, a written explanation must be provided.

Without prejudice to criminal action and/or debarment of up to three years from interviews conducted by AIIMS Deoghar, the candidature will be summarily cancelled at any stage of admission in respect of a candidate found to have:

- Obtained support for his/her candidature by any improper means.
- Impersonated, or procured impersonation by any person.
- Submitted fabricated or tampered documents.
- Made incorrect or false statements, or suppressed material information.
- Resorted to any other irregular or improper means in connection with the candidature.
- Intimidated or caused bodily harm to staff engaged by AIIMS Deoghar for the conduct of the interview.

### **14. Other Important Points**

---

- Fill the application carefully; changes after submission may not be possible, and further correspondence in this regard will not be entertained.
- Amendment, rectification, change or editing of Name, Category, Department and PWBD status is NOT allowed once submitted. Any change in address, mobile number or e-mail ID must be intimated to the office immediately.
- The Competent Authority reserves the right to amend, cancel or change this admission notice in whole or in part, without assigning any reason or giving prior notice.
- If any information or declaration is found to be false, or material information is wilfully suppressed, the candidate is liable to be removed from the Institute and such action as deemed fit may be taken.
- The decision of the Competent Authority regarding selection shall be final and no representation will be entertained.
- Names of selected/eligible candidates will be displayed on the Institute website within approximately one month; no separate individual intimation will be sent. Candidates must regularly visit [www.aiimsdeoghar.edu.in](http://www.aiimsdeoghar.edu.in) for updates.

- No verification of documents will be carried out before the interview; candidates must satisfy themselves regarding eligibility. Verification of original documents will be carried out at the time of admission.
- The applicant is responsible for the authenticity of submitted information, documents and photograph; any falsity or suppression shall lead to rejection/cancellation.
- There is no provision for re-checking or re-evaluation, and no query in this regard will be entertained.
- The decision of the Executive Director & CEO of the Institute shall be final in the matter of selection, and no appeal will be entertained.
- Selected candidates must join on the date stipulated in the selection letter, failing which the selection/admission shall stand cancelled.
- The selected candidate must submit the original permanent registration certificate, or an undertaking on a ₹100 stamp, within one month of reporting, failing which the candidature will be cancelled.
- Selection is subject to medical fitness; no candidate will be permitted to pay the course fee or join unless declared medically fit by the Institute's Medical Board, whose decision shall be final.
- Private practice in any form during the course is prohibited; the training is strictly full-time and continuous.
- The rules are subject to change in accordance with the decisions of the Institute from time to time.
- All disputes are subject to the jurisdiction of the courts of law in Jharkhand.
