- Admission for MBBS 2024Batch 1<sup>st</sup> Round of Counseling at MCC will start from 24<sup>th</sup>Aug, 2024 from 9AM to 1 PM and continue till 29<sup>th</sup>August, 2024 up to 5 PM. Admission for MBBS 2024 Batch 2<sup>nd</sup> Round of Counselling at MCC will start from 14<sup>st</sup>Sept, 2024 9AM onwards till 20<sup>th</sup>, Sept2024 up to 5 PM.
- Candidates selected are advised to see the Forms/Documents/Drafts in the Notice Section of AIIMS Deoghar Website. Candidates are to attend physically for the admission process. The Enclosed Documents has been put up in the Notice Section Student Column of the AIIMS Deoghar Website.
- Candidates for MBBS Admission 2024 Batch are required to bring along with them the original
  documents as in the Checklist of MBBS 2024 Admission along with one Xerox of self-attested
  documents in sequential order as in the Checklist.
- Candidates are advised to download and fill up all the enclosed forms of MBBS Admission which will ensure the admission process hassle free.
- No accommodation will be provided because of the current pandemic situation. The Circular regarding classes will be issued in due course of time.
- Admission process may spill over to the next day and candidates are required to do the needful before their arrival at Deoghar. Hence they are also advised to come before the last date of admission.

#### **ELIGIBILITY CRITERIA FOR MBBS ADMISSION IN AIIMS DEOGHAR**

#### 1. <u>CATEGORY-</u>

#### A. CRITERIA FOR OTHER BACKWARD CLASSES (NON-CREAMY LAYER) [OBC]

Reservation for OBC (Non-Creamy Layer) shall be according to the rules of the Government of India. Applicants are required to ensure that he/she does not belong to the persons/sections (Creamy Layer) mentioned in Column 3 of the Schedule to the Government of India, Department of Personnel & Training O.M. No. 36012/22/93-Estt. (SCT) dated 08/09/93 which is modified vide OM No. 36033/3/2004 Estt. (Res.) dated 09/03/2004 or the latest notification of the Government of India (i.e. Central list). A format is provided at the end of the Prospectus. The OBC certificates issued from 24/08/2023 to 24/08/2024 (inclusive) will be considered valid as the starting of reporting of Round-1 of MBBS counselling schedule (24/08/2024) as notified by (Medical Counselling Committee for MBBS admission).

#### B. CRITERIA FOR SCHEDULED CASTE/ SCHEDULED TRIBE (SC/ST)

Reservation for SC/ST candidates will be according to the rules of Government of India. Applicants will be required to produce the necessary certificate in the format provided. During counseling the certificate as prescribed in M.H.A., O.M., No. 42/21/49-N.G.S. dated the 28.1.1952, as revised in Dept. of Per-& A.R. letter No. 36012/6/76-Est. (S.CT), dated the 29.10.1977, to be produced by candidate belonging to a Scheduled Caste or a Scheduled Tribe in support of his/her claim.

#### C. CRITERIA FOR PERSONS WITH BENCHMARK DISABILITY (PWBD)

In accordance with the provisions of the Rights of Persons with Disabilities Act, 2016, 5% seats of the annual sanctioned intake capacity shall be filled up by candidates with benchmark disabilities, based on the merit list of Entrance Examination 2021. For this purpose the Specified Disability contained in the Schedule to the Rights of Persons with Disabilities Act, 2016 is annexed in APPENDIX-1. The candidate must possess a valid document certifying his/her physical disability. The disability certificate should be certified by a duly constituted and authorized Medical Board of the State or Central Govt. Hospitals/Institutions. All PWBD candidates shall be evaluated by a Medical Board of the Institute to determine eligibility.

#### D. CRITERIA FOR ECONOMICALY WEAKER SECTION (EWS)

Reservation for EWS shall be according to the rules of the Government of India. Applicants will be required to produce the necessary certificate in the format provided at the end of the prospectus in support of his/her claim. Certificate to be produced during Seat Allocation should be issued from 01/04/2024 to 24/08/2024 will be considered validas the starting of reporting of Round 1 - MBBS counseling (24/08/2024) schedule as notified by (Medical Counselling Committee for MBBS admission).. EWS certificate is valid only if issued on the basis of income from all sources for the financial year 2023-24 and valid for the year 2024-25.

#### E. <u>**AGE-**</u>

Should have attained or will attain the age of 17 (seventeen) years as on the 31st of December of the year of admission (2024). Candidates born on or before 31 December 2007 are eligible toapply.

- Candidate should have passed the 12<sup>th</sup>Class under the 10+2 Scheme/ Senior School Certificate Examination (CBSE) or Intermediate Science (I.Sc.) or an equivalent Examination of a recognized University/ Board of any Indian State with ENGLISH, PHYSICS, CHEMISTRY and BIOLOGY as subject. The candidates who have passed 10+2 level with Biology as an additional subject will also be eligible for MBBS Entrance Examination (as per Honable High Court Order No.2341/-W/DHC/WRITS/D-1/2019 dated 24/09/2019 in the Writ Petition (C)No. 6773/2019)
- Candidates who have appeared or are appearing at the qualifying Examination with English, Physics,
  Chemistry and Biology as main subject and expect to pass the Examination with required percentage
  of marks (as indicated in Sl No. 03 below) are also eligible to apply and appear in the Competitive
  Entrance Examination. However, their candidature will be considered only if they provide
  documentary evidence of having passed the qualifying Examination with the required subjects and
  percentage of marks.
- If the institute has to consider an examination of an Indian university or of a foreign/university to be equivalent to the 12th class under 10+2 scheme/intermediate science examination, the candidates shall have to produce a certificate from the concerned Indian university/Association of Indian Universities to the effect that the examination passed by him/her is considered to be equivalent to the 12th class under 10+2 scheme/intermediate science examination.

Note: The Essential Academic Qualifications for AIIMS are different from those prescribed by MCC for other Medical Colleges (Note: Annexure-I of NEET (UG) 2024 Information Bulletin)

#### 2. <u>MINIMUM MARKS-</u>

- The minimum aggregate of the marks in ENGLISH, PHYSICS, CHEMISTRY and BIOLOGY obtained in the qualifying examination (as in the essential qualification at Sl. No. 2 of this table) required for appearing in this examination are:
- General and OBC candidates: 60% SC/ST candidates: 50% & PWBD candidates: 45%
- Those with CGPA grades only will have to apply the conversion factor in the application form. The conversion factor should be as approved by their respective examination board.

## **Appendix–1: Specified Disability Clause**

A SCHEDULE is annexed regarding, "SPECIFIED DISABILITY" clause of section 2, that states as under,

#### 1. Physical disability

- A. Loco motor disability (a person's inability to execute distinctive activities associated with movement of self and objects resulting from affliction of musculoskeletal or nervous system or both), including—
- (a) "Leprosy cured person" means a person who has been cured of leprosy but is suffering from—
- (i) Loss of sensation in hands or feet as well as loss of sensation and paresis in the eye and eye-lid but with no manifest deformity;
- (ii) Manifest deformity and paresis but having sufficient mobility in their hands and feet to enable them to engage in normal economicactivity;
- (iii) Extreme physical deformity as well as advanced age which prevents him/her from undertaking any gainful occupation, and the expression "leprosy cured" shall construed accordingly;
- (b) "Cerebral palsy" means a Group of non-progressive neurological condition affecting body movements and muscle coordination, caused by damage to one or more specific areas of the brain, usually occurring before, during or shortly after birth;
- (c) "Dwarfism" means a medical or genetic condition resulting in an adult height of 4 feet 10 inches (147 centimeters) or less;
- (d) "Muscular dystrophy" means a group of hereditary genetic muscle disease that weakens the muscles that move the human body and persons with multiple dystrophy have incorrect and missing information in their genes, which prevents them from making the proteins they need for healthy muscles. It is characterized by progressive skeletal muscle weakness, defects in muscle proteins, and the death of muscle cells and tissue;
- (e) "Acid attack victims" means a person disfigured due to violent assaults by throwing of acid or similar corrosive substance.

#### **B.** Visual impairment-

- (a) "Blindness" means a condition where a person has any of the following conditions, after best correction—
- (i) total absence of sight; or
- (ii) Visual acuity less than 3/60 or less than 10/200 (Snellen) in the better eye with best possible correction; or 92
- (iii) Limitation of the field of vision subtending an angle of less than 10 degree.
- (b) "Low-vision" means a condition where a person has any of the following conditions, namely: (i) visual acuity not exceeding 6/18 or less than 20/60 upto 3/60 or upto 10/200 (Snellen) in the better eye with best possible corrections or
- (ii) Limitation of the field of vision subtending an angle of less than 40 degree up to 10 degree.

#### C. Hearing impairment -

- (a) "Deaf" means persons having 70 DB hearing loss in speech frequencies in both ears;
- (b) "Hard of hearing" means person having 60 DB to 70 DB hearing loss in speech frequencies in both ears;
- **D. "Speech and language disability"** means a permanent disability arising out of conditions such as laryngectomy or aphasia affecting one or more components of speech and language due to organic or neurological causes.

2. Intellectual disability, a condition characterized by significant limitation both in intellectual functioning

(reasoning, learning, problem solving) and in adaptive behavior which covers a range of every day, social and practical skills,including—

- (a) "specific learning disabilities" means a heterogeneous group of conditions wherein there is a deficit in processing language, spoken or written, that may manifest itself as a difficulty to comprehend, speak, read, write, spell, or to do mathematical calculations and includes such conditions as perceptual disabilities, dyslexia, dysgraphia, dyscalculia, dyspraxia and developmental aphasia;
- (b) "autism spectrum disorder" means a neuro-developmental condition typically appearing in the first three years of life that significantly affects a person's ability to communicate, understand relationships and relate to others, and is frequently associated with unusual or stereotypical rituals or behaviors.
- **3. Mental behavior,** "mental illness" means a substantial disorder of thinking, mood, perception, orientation or memory that grossly impairs judgment, behavior, capacity to recognize reality or ability to meet the ordinary demands of life, but does not include retardation which is a condition of arrested or incomplete development of mindof a person, specially characterized by sub normality of intelligence.

#### 4. Disability caused due to—

#### (a) Chronic neurological conditions, such as—

- (i) "Multiple sclerosis" means an inflammatory, nervous system disease in which the myelin sheaths around the axons of nerve cells of the brain and spinal cord are damaged, leading to demyelination and affecting the ability of nerve cells in the brain and spinal cord to communicate with each other;
- (ii) "Parkinson's disease" means a progressive disease of the nervous system marked by tremor, muscular rigidity, and slow, imprecise movement, chiefly affecting middle-aged and elderly people associated with degeneration of the basal ganglia of the brain and a deficiency of the neurotransmitter dopamine.

#### (b) Blood disorder—

- (i) "hemophilia" means an inheritable disease, usually affecting only male but transmitted by women to their male children, characterized by loss or impairment of the normal clotting ability of blood so that a minor would may result in fatal bleeding;
- (ii) "Thalassemia" means a group of inherited disorders characterized by reduced or absent amounts of hemoglobin.
- (iii) "Sickle cell disease" means a hemolytic disorder characterized by chronic anemia, painful events, and various complications due to associated tissue and organ damage; "hemolytic" refers to the destruction of the cell membrane of red blood cells resulting in the release of hemoglobin.
- **5. Multiple Disabilities** (more than one of the above specified disabilities) including deaf blindness which means a condition in which a person may have combination of hearing and visual impairments causing severe communication, developmental, and educational problems.
- 6. Any other category as may be notified by the Central Government.

Note: Any amendment to the Schedule to the RPWD Act, 2016, shall consequently stand amended in the above schedule.

### CHAPTER 4 – ALL AIIMS ACROSS THE COUNTRY

There will be four rounds of counselling i.e. Round 1, Round 2, Mop-Up Round & Stray Vacancy Round for all AIIMS across the Country which will be conducted by MCC. All the candidates who have qualified for NEET-UG on the basis of their rank in NEET UG conducted by NTA will be eligible. Eligible candidates may download the Rank letter/Result from NTA website.

Certain specific eligibility conditions of AIIMS are different from those highlighted in the NTA Information Bulletin. Eligible and willing candidates are advised to keep a note of the same before choice-filling. A copy of the same is annexed at <u>Annexure-7</u>

Candidates are advised to go through the Information Bulletin of AIIMS for checking the eligibility conditions, seat status etc. before applying for the same. In case the said eligibility conditions are not fulfilled, the seat is likely to be cancelled.

### Reservation Policy for AIIMS:

The reservation policy of the Central Government is followed and the same is applied only on the seats contributed by AIIMS to MCC:

- ➤ S.C.- 15%
- ➤ S.T.- 7.5%
- O.B.C.- (Non-Creamy Layer) as per the Central OBC list- 27%
- ➤ EWS- as per Central Government norms- 10%
- ➤ PwD- Horizontal Reservation as per NMC norms- 5%
- Foreign National seats\*\*

Candidates who want to avail 5% PwD reservation in UG seats of Govt. /Central medical institutions should obtain Disability certificate as per NMC norms (Gazette Notification no. The online certificate issued by the designated disability center through software provided by Medical counselling committee will be eligible, any other certificate issued by any other hospital/ board will not be accepted.

\*\* For the Foreign National seats only OCI/PIO/Foreign Nationals candidates will be eligible.

The fees for the Foreign National seats will be determined by AHMS Authorities.

#### Roster:

The roster for the 100% AIIMS seats shall be applied by the MCC of DGHS, MoHFW.

#### Eligibility Condition for AIIMS:

- The Candidate should have qualified NEET UG.
- 2. Domicile free.
- 3. Eligibility conditions as per AIIMS will be applicable.
- The conversion of seats will be carried out during the Mop-Up Round for AIIMS. The said conversion will be done only when the eligible Candidates belonging to the said Conversion Category have exhausted.
