ELIGIBILITY FOR ADMISSION:

General Eligibility: A Candidate seeking admission to the course for study leading to the award of a Degree of Doctor of Philosophy must possess at least one of the following qualifications:

A)Non-Medical/Life Sciences/Social Behavioral Sciences : The candidates with the following qualifications will be eligible:

The candidates who have passed M.Sc./MA/ Master of Physiotherapy or its equivalent examination with at least 55% marks in the subjects mentioned below from the colleges/institutes recognized by the UGC are eligible.

Non-Médical/Life Sciences : A degree of Master of Sciences (M.Sc.) or Master in Veterinary Science (M.V.Sc.) or M.Sc. (Laboratory Technology) in subjects allied to Medical Sciences such as Anatomy, Physiology, Biochemistry, Biophysics, Human Biology, Molecular Biology, Microbiology, Biotechnology, Immunology, Life Sciences including Botany, Zoology, Genetics, Cell Biology and Organic Chemistry.

Social Behavioral Sciences: The candidates with the following subjects are eligible for Social Behavioral Sciences, Anthropology, Psychology, Sociology, Social Work, Nutrition, Child Development. MA/M.Sc./M.Phil. in Health Promotion/Education, Health Management, Epidemiology, Environmental Health/Environmental Sciences and Public Health, Nutrition/Applied Nutrition/Food & Nutrition, Health Economics/Applied Economics/Economics, Public Health/Community Health and MPH and its equivalent.

For PhD Nursing: A degree of M.Sc. Nursing [any specialty] with at least 60% marks from recognized university with valid Registration from any state government Nursing Registration council.

NOTE: Candidates working under Central Govt/Semi Govt/Autonomous organization should submit their application through proper channel i.e. through the employer. A 'No objection certificate' is mandatory from the employer before joining the PhD programme.

Relaxation in Qualification for all Candidates.

A relaxation of 5% of marks from 55% or an equivalent relaxation of percentile / grade, may be allowed for those belonging to SC/ST/OBC (non-creamy layer)/Differently-abled Candidates.

PROCEDURE FOR APPLYING:

Before applying, the candidates are advised to go through the admission notice and prospectus displayed at the AIIMS DEOGHAR website and published in the press carefully. Fill in the application form in accordance with the instructions. Please ensure that no column is left blank. Incomplete application will not be considered and no correspondence will be entertained.

Applicants for Ph.D. course should choose department and indicate the code on application form.

DURATION OF THE COURSE:

Duration of course for all Candidates will be from the date of provisional registration to submission of thesis with a minimum duration of three years. However, the maximum period of registration shall not exceed six years.

PhD course will be full time.

METHOD OF SELECTION:

Selection for PhD registration will be after ***Personal Interaction with Interview Selection Board and Department based assessment.*** The interview selection board shall be approved by the competent authority.

In the event of a tie, preference shall be given to the candidate who is senior in age as per date of birth.

Note:

Result will be available on website of AIIMS. No individual intimation will be communicated to Candidate.

HOSTEL ACCOMMODATION: As per availability

LEAVES : Ph.D students are entitled for 30 days leave every year and leaves of multiple years cannot be clubbed together. If leave availed exceeds 30 within a year, then the period beyond 30 days is treated as Extra Ordinary Leave (EOL) and the minimum registration will be extended for the same duration as EOL. However, EOL cannot be more than 3 months in the entire registration period of 5 years. Any such availment beyond 3 months shall lead to the registration being cancelled.

Other leaves entitled will be as per the rules.

Any dispute in regard to any matter referred to herein shall be subject to the jurisdiction of the Deoghar Courts alone.
