
Important Instructions for Candidates:

1. On 17th April 2026, document verification for all provisionally eligible candidates, who had applied for **Data Entry Operators**, will be conducted by the duly constituted committee. Only those candidates, who are found eligible after successful document verification will be permitted to appear for **typing speed test** followed by the interview.
2. On 17th April 2026, **Written test** will be conducted (if more than 30 eligible candidates report on the day) for candidates, who had applied for **Project technical Support III**, to shortlist 15 candidates followed by **document verification** for shortlisted candidates, by the duly constituted committee. If less than 30 candidates report, all will be allowed for document verification. Only those candidates, who are found eligible after successful document verification will be permitted to appear for the interview.
3. On 18th April 2026, document verification for all provisionally eligible candidates, who had applied for **Project Technical Support II**, will be conducted by the duly constituted committee.
