5. The IEMs suggested to elaborate following clause with example:

The value of executed works shall be brought to current. Costing level by enhancing the actual value of work at simple rate of 7% per annum; calculated. from the date of completion to last date of submission of bids.

Example: If a bidder has executed the work in Dec. 2021 amounting ₹ 30,00,000.00 then the current value will be brought as given below:

P= ₹ 30,00,000.00

R = @7% per annum

T= 4 Years

$$\begin{aligned}\text{Current Amount} &= P (1 + r/100)^t \\ &= 30,00,000 (1+7/100)^4 \\ &= ₹ 39,32,388.00\end{aligned}$$

Any items or works not mentioned above but required for intended output is included in the scope.

All queries raised during the pre-bid meeting were duly discussed and clarified. No further modifications to the tender conditions were agreed upon.
