1. Terms & Conditions:

- a) The quotations received after the deadline or unsealed shall not be entertained under any circumstances whatsoever. In case of postal delay this Institute will not be responsible. The offer submitted by Fax / email shall not be considered and no correspondence will be entertained in this matter.
- b) Quotations must be in the **enclosed prescribed Performa** (Annexure -2) on the letter head of the firm duly signed by the Proprietor/ Partner/ Director or their authorized representative, In case of signing of quotation by the authorized representative letter of authorization must be attached with the quotation.
- c) Rates must be quoted in Indian rupees.
- d) Rates must be **quoted including all charges** (including Freight charges, Insurance, installation, taxes etc.) at Deoghar.
- e) No overwriting or cutting is permitted in the rate. If found, the quotation shall be summarily rejected.
- f) The rates quoted must be valid for 90 days minimum from the date of opening of the quotation.
