NOTICE INVITING QUOTATION

Subject: Invitation of quotation for supply & fixing of LED flood lights, Street lights and related accessories in AIIMS Deoghar, P.T.I Daburgram, Jasidhi Jharkhand.

Sealed Quotations are invited on behalf of AIIMS, Deoghar for supply & fixing of LED flood light (150 watt, 100 watt.), Street light (40 watt), Single core flexible copper cable(4sq mm, 1.5 sq mm), MCB(32 amp dp), PVC pipe(20 mm), PVC Flexible pipe(20 mm) & PVC saddle(20 mm) etc in AIIMS Deoghar as per details terms & conditions mentioned below. The filled quotations along with all the required document must reach within 10 (ten) days from the date of issue of quotation to "The Administrative Officer, AIIMS Deoghar, P.T.I Campus, Jasidhi, Jharkhand, Pin code: 814142". Volume of work and specification is annexed as Annexure 1.

1. Terms & Conditions:-

- a) The quotations received after this deadline or unsealed shall not be entertained under any circumstances whatsoever. In case of postal delay this Institute will not be responsible. The offer submitted by Fax / email shall not be considered and no correspondence will be entertained in this matter.
- b) Quotations must be in the enclosed prescribed Performa (Annexure -2) on the letter head of the firm duly signed by the Proprietor/ Partner/ Director or their authorized representative, In case of signing of quotation by the authorized representative letter of authorization must be attached with the quotation.
- c) Rates must be quoted in Indian rupees.
- d) Rates must be quoted including all charges (including Freight charges, Insurance, installation, GST, taxes etc.) at Deoghar
- e) **No overwriting or cutting** is permitted in the rate. If found, the quotation shall be summarily rejected.
- f) The rates quoted must be valid for 90 days minimum from the date of opening of the quotation.
- g) L1 will be decided on the basis of total cost/ amount. Becoming L1 will not be the criteria for awarding of supply/purchase order unless the rates are reasonable & justified.
- h) The firm / agency may satisfy the following conditions and attach self-attested copy of the same with the quotation:-
 - The firm shall have valid GST / Other taxes and IT PAN.
 - Supply/Purchase order of government institute/other AIIMS where similar work was done by the bidder.

- o) AIIMS, Deoghar reserves the right to reject any quotation or part or the whole of inviting quotation process without assigning any reason. Decision of The Executive Director, AIIMS, Deoghar, will be final in this regard.
