1. Terms & Conditions:

- a) The quotations received **after this deadline or unsealed shall not be entertained** under any circumstances whatsoever. In case of postal delay this Institute will not be responsible. The offer submitted by Fax / email shall not be considered and no correspondence will be entertained in this matter.
- b) Quotations must be in the **enclosed prescribed Performa (Annexure -1) on the letter head of the firm duly signed** by the Proprietor/ Partner/ Director or their authorized representative, in case of signing of quotation by the authorized representative letter of authorization must be attached with the quotation.
- c) The bidder should supply all the equipment's / items along with its accessories.
- d) Rates must be quoted in Indian rupees.
- e) Rates must be inclusive of all charges (including Freight charges, Insurance, installation, taxes etc.).
- f) **No overwriting or cutting** is permitted in the rate. If found, the quotation shall be summarily rejected.
- g) The **rates quoted must be valid for 90 days minimum from the date of opening of the quotation** and silence of any tendered on this issue shall be treated as agreed with this condition.
- h) **Total cost/amount will be taken in consideration for L1. Becoming L1** will not be the criteria for awarding of purchase order unless the rates are reasonable & justified.
- i) The firm / agency may satisfy the following conditions and **attach self-attested copy of the same with the quotation: -**
 - The firm shall have valid GST / Other taxes and IT PAN.
 - The firm should not be black listed by any Government agency/Department.

- j) Quotations qualified by such vague and indefinite expressions such as “subject to prior confirmation”, “subject to immediate acceptance” etc. will be treated as vague offers and it will be rejected accordingly. Any conditional quotation shall be rejected summarily.
- k) The Bidders who have not obeyed the previous work order will not be allowed to participate in the NIQ.
- l) **Liquidated Damage:** - If the supplier fails to deliver the material on or before the stipulated date, then a penalty at the rate of 0.5 % per week of the total order value shall be levied subject to maximum of 10% of the total order value.
- m) **Payment Terms:** 100% Payment will be only released after successful completion of work.
- n) **Disputes:** -In the event of any dispute or disagreement arising between the contractors and any other department of AIIMS Deoghar with regards to the interpretation of “Terms & Conditions” of this inquiry, the same shall be referred to arbitrator appointed by The Executive Director, AIIMS, Deoghar, whose decision will be final and binding upon the contractor.
- o) AIIMS, Deoghar reserves the right to increase or decrease quantity. Decision of Quantity of items in the AIIMS, Deoghar will be final in this regard.
- p) AIIMS, Deoghar reserves the right to reject any quotation or part or the whole of inviting quotation process without assigning any reason. Decision of The Executive Director, AIIMS, Deoghar, will be final in this regard.
- q) The envelope containing quotation should be sealed with wax/ tape from both the sides. No quotation will be accepted if received after due date.

TERMS AND CONDITIONS:

1. The work should be carried out strictly as per the specifications and as per the directions of the Engineer-in-charge.
2. Safety measures as specified in CPWD general conditions of contract should be adopted to protect the labour from every risk specifically while cleaning the tank.
3. Before tendering, the contractor shall inspect site of work and shall fully acquaint himself about the conditions prevailing at site, availability of materials in market,
4. Availability of ready site and suitable locations for execution of the work involved in achieving the completion of work.
5. The contractor shall at his own expense and risk arrange the storage of materials at site of the work for carrying out of all jobs connected with the completion of the work. The contractor shall have to abide by the regulations of the authorities concerned and the directions of the I/c Engineering Section. If during construction, it becomes necessary to remove or shift the equipment, material, etc, to facilitate execution, the contractor shall carry out the removal of shifting as directed by the Executive Engineer and re-shift to its original position and no claim whatsoever, shall be entertained on this account.
6. It shall be deemed that the contractor has satisfied himself as to the nature and location of the work, transport facilities, availability of site, etc. the department will bear no responsibility for lack of such knowledge & the consequences thereof.
7. The I/c Engineering Section shall have full powers for removal of any or all of the materials brought to site by contractor which are not in accordance with the contract specifications or do not conform, in character or quality. In case of default on the part of the contractor in removing rejected materials, the Officer-in-charge shall be at liberty to have them removed at the risk and cost of the contractor.
8. The work shall be carried out in such a manner so as not to interfere / or adversely / or disturb the functioning of the Institute and other works being executed by other agencies, if any.
9. Any damage done by the contractor to any existing work or work being executed by other agencies shall be made good by him at his own cost.
10. The contractor shall maintain in good condition all work executed till the completion of entire work entrusted to the contract under this contract.
11. No payment shall be made to the contractor for damage caused by rain, flood and other natural calamities whatsoever during the execution of works and any damage to the work on this account shall have to be made good by the contractor at his own cost.
12. The Contractor shall take instructions from the In charge Engineering Section regarding collections and stacking of materials at site.
13. The Contractor shall be responsible to arrange at his own cost all necessary tools and tackles required for execution of the works including incidental original and maintenance works.
14. The operating cost of contractor's machinery at site, if any shall be borne by the contractor himself.
15. The Institute shall not be responsible for any injury partial or permanent or death of any workers at site due to accident or malfunctioning of the equipment or by negligence of the Contractors staff on site.
16. All applicable and prevailing taxes will be recovered from the bills as applicable from time to time.
17. If any damage caused for public conveniences/ services, the same shall have to be repaired instant, failing which necessary recovery shall be made from the bill.

18. If any Building, Road and Channels will be damaged by the Contractor the same will have to repair by the Contractor at his risk and cost, otherwise the complete cost will be recovered as intimated by the Engineer-in-charge.
19. Price should be inclusive of all (transportation up to AIIMS Deoghar and all other incidental expenditure, if any).
20. Price of the items, GST% should be indicated separately.
21. No advance payment will be made.
22. Verbal quotation or incomplete quotation will be rejected.
23. Any variation in the specification(s) during repair/servicing will be rejected.
24. Time allowed is 30 days and starts from the date of issue of Work Order. In case of delay in completion of the contract, Liquidate damages (LD) at one percent of the contract value per week of delay subject to a maximum of ten percent of contract value shall be levied
25. The work shall be carried out to the entire satisfaction of the Engineering in-charge of AIIMS Deoghar.
26. Payment shall be made on submission of Invoice after satisfactory execution of the work and as per actual measurements
27. The rates quoted are net and nothing extra shall be paid on any account.
28. The tax as applicable shall be deducted from the gross amount of the bill.
29. Before starting the work submit the sample of respective work to engineering section and take the approval.

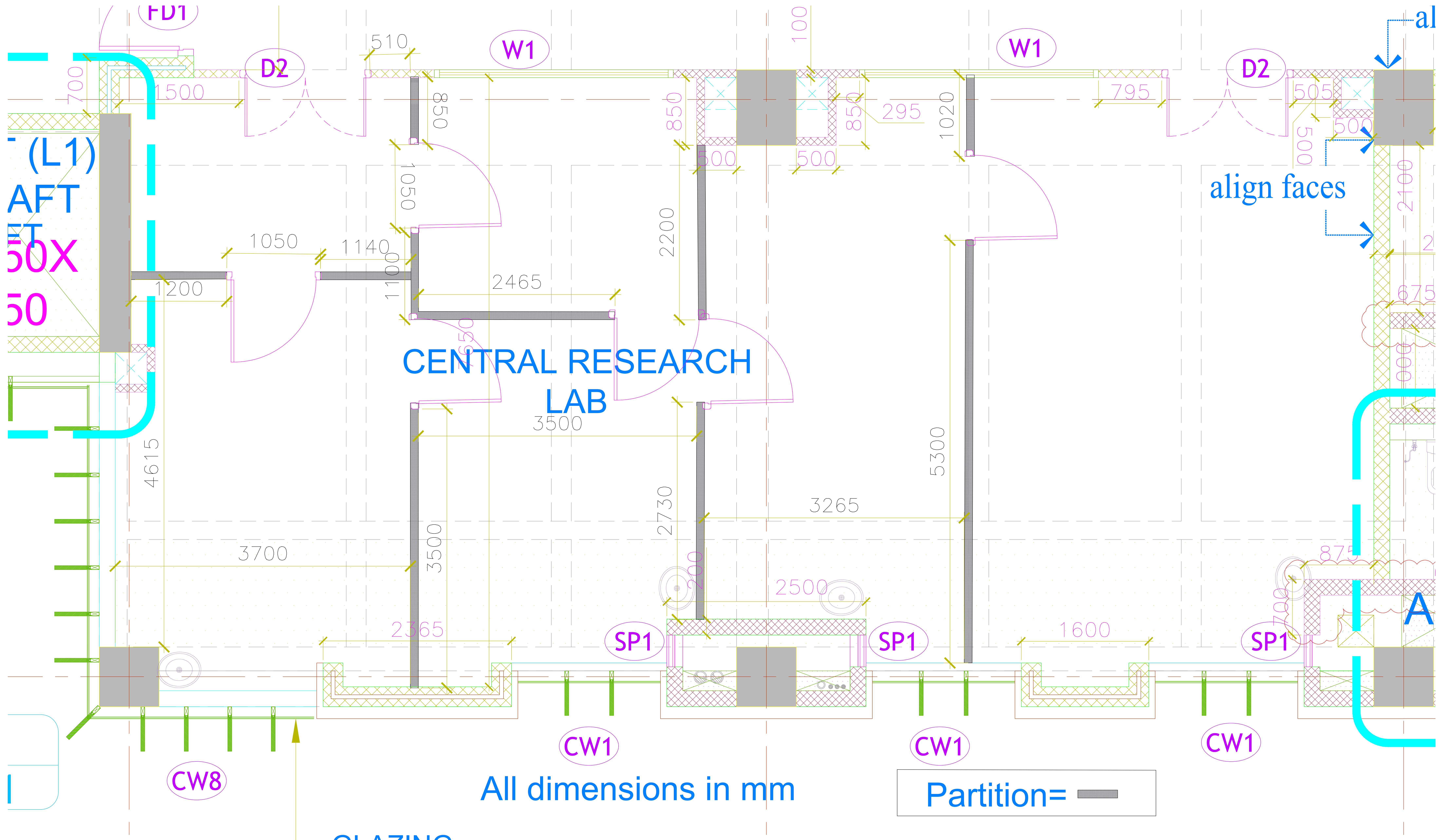

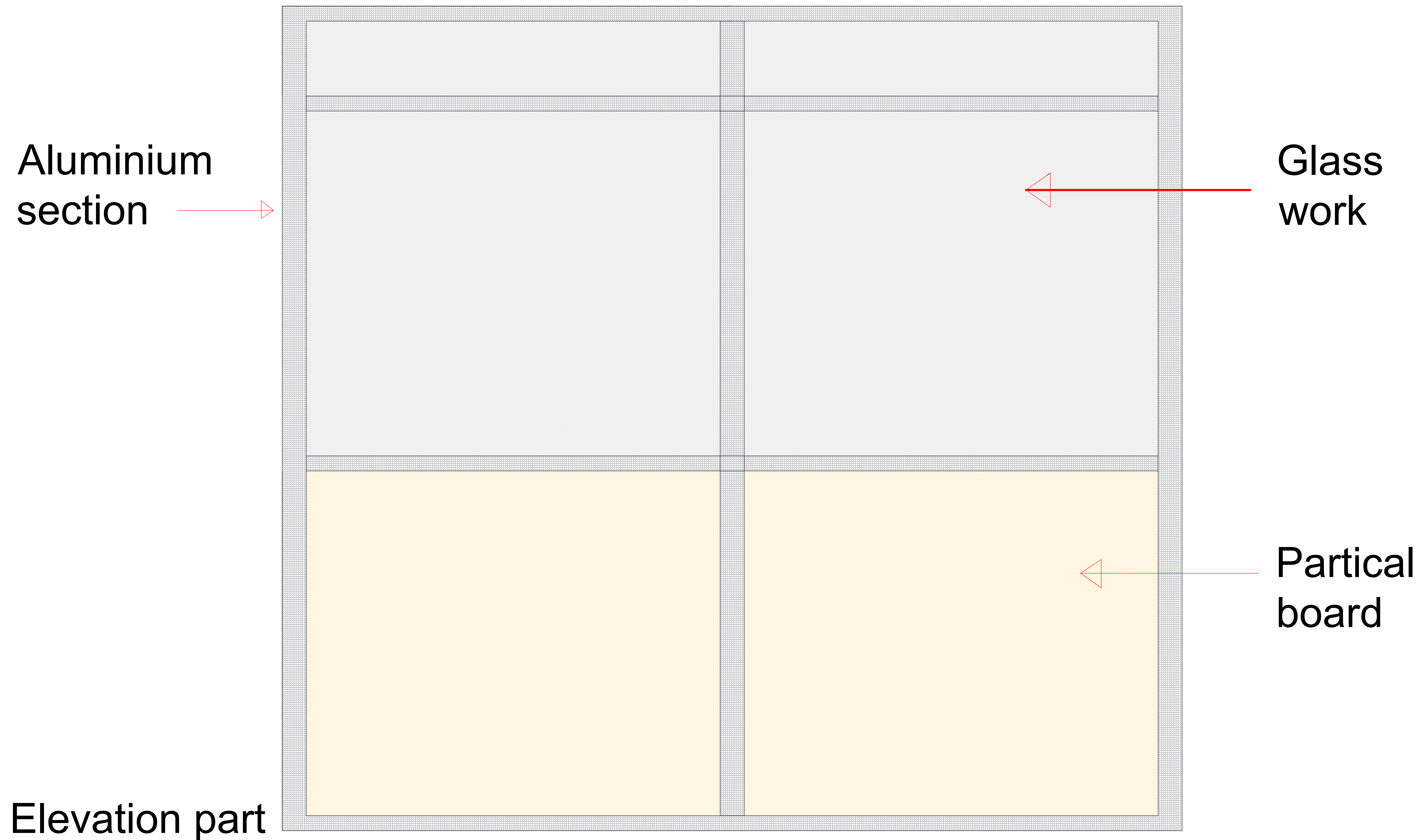
