### **Terms & Conditions:**


1. The quotations received **after this deadline or unsealed shall not be entertained** under any circumstances whatsoever. In case of postal delay this Institute will not be responsible. The offer submitted by Fax / email shall not be considered and no correspondence will be entertained in this matter.
2. Quotations must be in the **enclosed prescribed Performa (Annexure -1) on the letter head of the firm duly signed** by the Proprietor/ Partner/ Director or their authorized representative, in case of signing of quotation by the authorized representative letter of authorization must be attached with the quotation.
3. The bidder should supply all the equipment's / items along with its accessories.
4. Rates must be quoted in Indian rupees.
5. Rates must be inclusive of all charges (including Freight charges, Insurance, installation, taxes etc.).
6. **No overwriting or cutting** is permitted in the rate. If found, the quotation shall be summarily rejected.
7. The **rates quoted must be valid for 90 days minimum from the date of opening of the quotation** and silence of any tendered on this issue shall be treated as agreed with this condition.
