Terms & Conditions:

- The quotations received after this deadline or unsealed shall not be entertained under any circumstances whatsoever. In case of postal delay this Institute will not be responsible. The offer submitted by Fax / email shall not be considered and no correspondence will be entertained in this matter.
- Quotations must be in the enclosed prescribed Performa (Annexure -1) on the letter head of the firm duly signed by the Proprietor/ Partner/ Director or their authorized representative, in case of signing of quotation by the authorized representative letter of authorization must be attached with the quotation.
- 3. The bidder should supply all the equipment's / items along with its accessories.
- 4. Rates must be quoted in Indian rupees.
- 5. Rates must be inclusive of all charges (including Freight charges, Insurance, installation, taxes etc.).
- 6. No overwriting or cutting is permitted in the rate. If found, the quotation shall be summarily rejected.
- The rates quoted must be valid for 90 days minimum from the date of opening of the quotation and silence of any tendered on this issue shall be treated as agreed with this condition.
- 8. Total cost/amount will be taken in consideration for L1. Becoming L1 will not be the criteria for awarding of purchase order unless the rates are reasonable & justified.
- 9. The firm / agency may satisfy the following conditions and attach self-attested copy of the same with the quotation: -
 - The firm shall have valid GST / Other taxes and IT PAN.
 - The firm should not be black listed by any Government agency/Department.



- 10. Quotations qualified by such vague and indefinite expressions such as "subject to prior confirmation", "subject to immediate acceptance" etc. will be treated as vague offers and it will be rejected accordingly. Any conditional quotation shall be rejected summarily.
- The Bidders who have not obeyed the previous work order will not be allowed to participate in the NIQ.
- 12. Liquidated Damage: If the Firm fails to complete the work on or before the stipulated date, then a penalty at the rate of 0.5 % per week of the total order value shall be levied subject to maximum of 5% of the total order value.
- Security Deposit: Firm shall submit 2.5 % amount of supply order in the form of PBG. The security deposit shall be valid up to 2 months after the work completion period.
- 14. Payment Terms: 100% Payment will be only released after successful completion of work.
- 15. Disputes: -In the event of any dispute or disagreement arising between the contractors and any other department of AIIMS Deoghar with regards to the interpretation of "Terms & Conditions" of this inquiry, the same shall be referred to arbitrator appointed by The Executive Director, AIIMS, Deoghar, whose decision will be final and binding upon the contractor.
- 16. AIIMS, Deoghar reserves the right to increase or decrease quantity. Decision of Quantity of items in the AIIMS, Deoghar will be final in this regard.
- 17. AIIMS, Deoghar reserves the right to reject any quotation or part or the whole of inviting quotation process without assigning any reason. Decision of The Executive Director, AIIMS, Deoghar, will be final in this regard.
- The envelope containing quotation should be sealed with wax/ tape from both the sides. No quotation will be accepted if received after due date.
- 19. No advance payment will be made.
- 20. Verbal quotation or incomplete quotation will be rejected.
- 21. Time allowed is 30 days and starts from the date of issue of Work Order. In case of delay in completion of the contract, liquidate damages (LD) at one percent of the contract value per week of delay subject to a maximum of ten percent of contract value shall be levied
- 22. The work shall be carried out to the entire satisfaction of the Engineering in-charge of AIIMS Deoghar.
- 23. The rates quoted are net and nothing extra shall be paid on any account.
