- c) Labor for lifting, shifting of old ACs to site, tools & tackles are to be arranged by supplier.
- d) After commissioning, all ACs will be put under observation for a period of 1 week.
- e) Rates must be quoted in Indian rupees.
- f) Rates to be submitted with all break up of taxes, duties, transportation charges, time required for completion of work.
- g) The rates quoted must be valid for 90 days minimum from the date of opening of the quotation and silence of any tendered on this issue shall be treated as agreed with this condition.
- h) Total cost/amount will be taken in consideration for L1.
- i) The firm / agency may satisfy the following conditions and attach self-attested copy of the same with the quotation:
- The firm shall have valid GST / Other taxes and IT PAN.
 - The firm should not be black listed by any Government agency/Department.
 - Certificate of OEM or authorized dealership certificate.
- j) Quotations qualified by such vague and indefinite expressions such as “subject to prior confirmation”, “subject to immediate acceptance” etc. will be treated as vague offers and it will be rejected accordingly. Any conditional quotation shall be rejected summarily.

- k) Earnest Money Deposit (EMD): The bidder will be required to deposit a sum of Rs.4,300/- towards Earnest Money deposit except MSME bidder. Bid submitted without EMD will be summarily rejected. EMD to be submitted in the form of BG/Demand Draft in favor of beneficiary.
- l) Performance Security Deposit: To be submitted in the form of BG / FD equivalent to 5% amount of ordered value & valid up to 1 year from the date of acceptance of all ACs.
- m) **Liquidated Damage:** - If the supplier fails to organize event/ deliver the material on or before the stipulated date, then a penalty at the rate of 0.5 % per week of the total order value shall be levied subject to maximum of 10% of the total order value.
