# **Guidelines**

### 1. Objective

To provide financial assistance to the poor and meritorious students to meet a part of their academic expenditure while pursuing an undergraduate course in the Institute.

# **2. Scholarship Amount (for the period from 31.08.2025 to 30.08.2026)**

- ₹50,000/- per student (to be re-reviewed for next academic year ).

#### 3. Beneficiaries

• Total 3 students from MBBS, Nursing and Paramedical course will be selected this year.

## 4. Eligibility Criteria

 $\Rightarrow$  Course of Study

Student pursuing a course of MBBS/Nursing/Paramedical.

#### $\Rightarrow$ Year of Study

- <u>MBBS course</u>: Must have passed the 1st year and be currently enrolled in the 2nd year, and respectively till the final year (not applicable to interns).
- **Nursing**: Must have passed the 1st year and be currently enrolled in the 2nd year, and respectively till the final year (not applicable to interns).
- <u>Paramedical</u>: Must have passed the 1st year and be currently enrolled in the 2nd year, and respectively till the final year (not applicable to interns).
- **Note:** Students who received the Ambuj Sonu Smriti Scholarship in the previous year are **not eligible** to apply again.

#### 5. Economic Status

- Annual Income of parents must be less than 08 lacs.
- You/your parents should not own agricultural land of size 5 acres or more.
- You/your parents should not own a residential flat of area 1000 square feet or more.
- You/your parents should not own a residential plot (in notified municipalities) of an area 100 square yards or more.

- You/your parents should not own a residential plot (other than in notified municipalities) of area 200 square yards or more.
- Notarised Affidavit duly sworn and signed by the Parent/Guardian on a hundred rupees stamp paper, quoting all the above-mentioned points

#### 6. Selection Criteria

The selection will be based on a weighted system as follows:

### A) Academic Performance (Merit Criteria): 30% weightage

- Marks and grades/Rank from the previous academic year.
- Consistency and improvement in academic performance and internal examinations.

### B) Research (if any): 30% weightage

• Involvement in research projects, publications, scientific presentations or scholarly activities.

# C) Extra-curricular Activities: 30% weightage

- Participation and achievements in extracurricular activities such as sports, annual day, arts, clubs, etc.
- Leadership roles or significant contributions in extracurricular domains.

## D) Organizational/Social/ Community Services: 10% weightage

• Participation in social or community services, including volunteering, and other community engagements. (non-academic).

#### 7. Application Process

#### ⇒ Submission (soft copy required)

- Dully filled scholarship application form (Annexure-1).
- Attach necessary documents as mentioned in the application form.
- Notarised Affidavit duly sworn and signed by the Parent/Guardian in a hundred rupees stamp paper.

(All the documents including notarised affidavit to be submitted in soft copy initially, but if the student is selected for the award, all the enclosed documents will be scrutinized in person/hard copy by the committee).

# **⇒** Review and Shortlisting

- Applications will be reviewed by the scholarship committee.
- Shortlisted candidates will be contacted for further evaluation if needed.

- Final selection will be based on the weighted criteria as described above.
- The name of selected students will be announced on annual day i.e. 16<sup>th</sup> September, 2024, and the scholarship will be awarded the same day.

- Application Start Date: 27<sup>th</sup> August 2025 (10:00 AM onwards)
- Application Deadline: 10<sup>th</sup> September 2025 (till 2:00 PM only)
- Announcement of Results: 16<sup>th</sup> September, 2025

\*Student availing the benefit of any other scholarship scheme will not be eligible for this scholarship. Duly signed declaration to be submitted by the student/parent for the same (Annexure-2).
